Officer's Corner

Where and how did this year (2014) go, and fly by so fast? As I put my thoughts together for this column, I quickly began to recall what our Club was busy doing this year.

We started the year in January with only 6 months to complete the plans and arrangements for the GTOAA Convention. The Steering Committee was meeting on a regular basis, and then meeting twice a month as we got closer to July. I know I speak for all that were involved with this event, the time just flew by for 6 months.

With a lot of help from our membership we were able to conduct that National Convention without any major problem, and, with great success. In fact it was said to many of us that this Convention was one of, if not the best convention that many of our guests attended. The compliments, and offers of Thanks to our Club, made all the work worthwhile.

This year's Family Picnic was held in September, and was attended by the most members ever. It was nice to see so many of our new members attend and all seemed to have a great time as usual.

Another event still yet to come this year is our annual Christmas party that will be held in December. Check out the Newsletter and watch your E Mails for more details about this event. We are anticipating another good time for all of you.

On the business side of things:

The club voted to require membership in the National GTOAA Organization for all of our present and future members beginning in January of 2015. Your local dues will NOT increase and will remain at \$10.00. We will however begin collecting the \$35.00 GTOAA yearly dues with your membership. All you will need to do is pay the \$45.00 total. Our Club Treasurer will then send 1 check off to the National organization and your GTOAA dues will be extended (If you are a present member) for an additional year regardless of when your GTOAA membership expires. Simply put, if your GTOAA membership expires in April of 2015, (presently) they will now extend to April of 2016, an additional year. New members that do not presently belong to the GTOAA will begin with membership in January 2015 and run until January of 2016. We hope that those that do NOT belong to the National organization will join with the rest of us and support the GTOAA. The efforts of the GTOAA to promote our "Hobby" go a very long way, in addition you will receive the monthly Legend Magazine subscription. Keep in mind that as a "Chapter" of the GTOAA our membership like all other Chapters, is required to maintain a certain % of membership to continue on as a chapter of the GTOAA, the requirements continue to increase. It will eventually reach a mandatory 100%. That is why our Club decided to do it now rather than later.

We were also able to "Welcome" our new Secretary Cheryl Kasper. Cheryl accepted the position and she is already doing a great job for us. She is working to complete a new roster of our membership. You should have seen a request for information from Cheryl, so please if you haven't responded please do so. The roster will be available soon to all our members.

I had asked at our October membership meeting for volunteers to "Head Up" several committees that I would like to begin. Those committees are 1) The Cruise

Committee / Fun Runs, East and West and 2) the Activities Committee, East and West. The thought is to have 2 groups working to offer suggestions to our members "West" and "East". We hope to minimize the complaint(s) of.... "it's too far to travel all that way". :) We can then offer cruise / show choices in both areas for our members to select, and certainly anyone can go to any cruise / show they choose. The Idea is to keep you informed and offer each of you choices. Brian George, and Jim Mastroinni will head up this effort, Brian (West) and Jimmy (East).

We still need 2 people to head up the Activities East and West. These people would offer choices for "Activities" mainly during the Fall and Winter months, i.e. Dinner out and perhaps Bowling, or a Gateway Clipper river boat ride and so on. Don't take this the wrong way but I think these positions are best left to the Female members or wives. So I'm still looking for 2 people to do this, 1 for the West, and 1 for the East. When I speak about West and East I'm suggesting that Rte. 8 be the dividing line between East and West.

Because of our Non For Profit Status, we are required to have By-Laws. 3 members, Jim Longo, Doug Sappington, and Ken Kasper, volunteered to do this task of forming the By-Laws, and they will bring their suggestions to the membership in the future.

Election of Officers will be held at our general membership meeting in January. Anyone that is interested in a club position should notify Cheryl or anyone of the other officers of the Club. We will be electing a President, Vice President, Secretary, and Treasurer at the January meeting. Nominations will begin at the November meeting.

100% GTOAA Membership

At the September general membership meeting, a proposal was presented for our club to become a 100% GTOAA membership club. The proposal was unanimously passed. What this simply means is that, beginning January 1, 2015, every member of our club must also be a member of the GTOAA.

In the past, the club has been lenient with dues. Now, ALL dues MUST be paid by 12/31 of the previous year. An active membership roster will be submitted to the GTOAA in early January. Dues will be \$45 (\$10 for our club and \$35 for the GTOAA). Please pay with one check payable to the Greater Pittsburgh GTO Club and send it to our secretary, Cheryl Kasper. Cheryl's address is 1230 Craig Drive, North Huntingdon, PA, 15642. The club will forward your dues to the GTOAA. Please do not renew directly with the GTOAA. Please also make sure you send your dues to Cheryl. With the 100% GTOAA membership, Cheryl has records that need to be up to date and accurate. Cheryl will coordinate with our Treasurer, Alan Fabritius.

Please note that our club membership runs January to December. Your GTOAA membership however will simply be extended by one year. If your GTOAA membership expires in July of 2015, for example, it will be extended to July of 2016.

In summary, every November or December, please send one \$45 check payable to the Greater Pittsburgh GTO Club to Cheryl Kasper. That one check will pay your Greater Pittsburgh GTO Club dues AND GTOAA dues. Cheryl must have all dues by 12/31. You will no longer need to renew directly with the GTOAA.

2015 Dues

Greater Pittsburgh GTO Club dues for 2015 are now due and must be paid by 12/31/2014! If you have not paid your 2015 dues, please send a check for \$45 payable to Greater Pittsburgh GTO Club to Cheryl Kasper. Cheryl's address is 1230 Craig Drive, North Huntingdon, PA, 15642.
